

Terms of Use

Hanlans Point Mooring Wall

All transient moorings are operated by Toronto Island Marina under an agreement with the Municipality of Metropolitan Toronto and all patrons shall be subject to the Municipality of Metropolitan Toronto By-law No. 103-78 as amended by By-law No. 118-78, 66-79, 99-80, 68-81, 129-81, 78-83, 38-82, 24-85, 56-87. A copy of By-laws is posted at the Marina and Transient Mooring Office. Further Notice is hereby given that any craft, floating dock or any other navigable conveyance remaining at a transient mooring over and beyond the 48-hour limit as stipulated in the above-noted By-laws is subject to being towed away and stored by Toronto Island Marina with all normal towing and storing charges being payable by the owner.

Toronto Island Marina shall not be liable for the care or protection of the boat (including her gear, equipment and contents) or for any loss or damage of whatever nature, to the boat (including her gear, equipment and contents) whether due to negligence of Toronto Island Marina, its agents or employees or to any other cause.

The boat owner indemnifies and holds Toronto Island Marina harmless against any loss, cost, suit or claim arising out of the use of any mooring space, or of any handling of the boat in connection therewith, whether or not such loss, cost, suit or claim is based upon negligence of Toronto Island Marina, its agents or employees, or to any other cause.

The boater agrees to comply with all posted By-laws, rules and regulations as and where they relate to transient moorings.

Mooring Regulations

1. In accordance with City By-law 591-2.1, No person shall emit or cause or permit the emission of continuous amplified sound, measured with a sound level meter at a point of reception in an outdoor living area: (1) That has a sound level exceeding 50 dB(A) or 65 dB(C) from 11 p.m. to 7 a.m. or 55 dB(A) or 70 dB(C) from 7 a.m. to 11 p.m.; or (2) Where the ambient sound level at a point of reception exceeds the maximum sound level permitted under Subsection A(1), that has a sound level equal to or exceeding the ambient sound level.
2. The use of Public Address System (PA) shall not be permitted on vessels or surrounding area of Hanlans Mooring Wall.
3. Check out shall occur no later than 2:00pm on the day of departure.
4. Rafting is not permitted which blocks or is a menace to navigation. Where permissible rafting occurs, users will be charged at the regular tariff for use of designated mooring space. A maximum of two (2) vessels may be rafted at any point in time.
5. In accordance with City By-law 608-13 Camping and Lodging, unless authorized by permit, no person shall dwell, camp or lodge in a park.
6. In accordance with City By-law 608-14 Tents and Structures, unless authorized by permit, no person shall place, install, attach or erect a temporary or permanent tent, structure or shelter at, in or to a park.
7. No refuse of any kind shall be thrown overboard or otherwise put into the waters or it approaches. Garbage shall be deposited in bins provided for that purpose.

- 8.** In accordance with City By-law 349-12 Dogs at large, (A) No owner of a dog shall cause or permit the dog to be at large in the City, including, but not limited to, upon or in any lands or grounds owned or operated by the City, such as sidewalks, curbs, boulevards, walkways or other public places owned by the City, except where expressly permitted by City by-law. (B) For the purposes of this chapter, a dog shall be deemed to be at large when found on property other than the property of the owner of the dog and not under the control of any person, including but not limited to the tethering of the animal.
- 9.** Shower codes provided to users of Hanlans Mooring Wall shall not be shared with the public, unless authorized by the Toronto Island Marina, its agents or employees.
- 10.** A maximum spacing of five (5) feet will be permitted between vessels moored on Hanlans Wall. Applicable fees will be charged to vessels using more than five (5) feet of wall space.
- 11.** Payment does not guarantee space, all mooring is first come first serve. Payment entitles boat to remain moored on Hanlans wall from time of payment to date of departure. Payment does not reserve your space if boat leaves wall for any reason during the stay. All information provided will be validated by our Dockmaster on duty.
